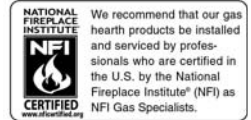

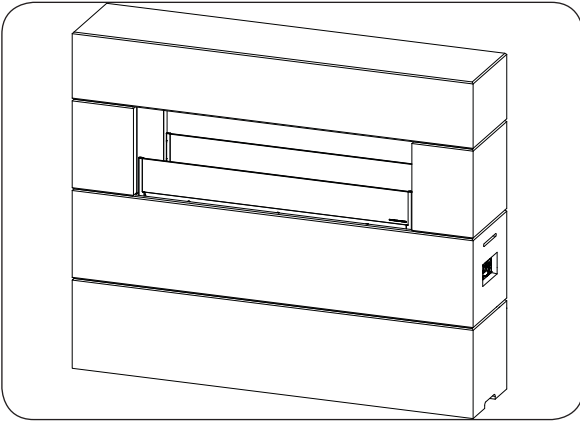

IMPORTANT SAFETY INFORMATION

Congratulations on your purchase of an American Fyre Designs outdoor gas fireplace. Made with pride in America, your new fireplace complies with national safety standards and when installed per these instructions and used as intended it will provide warmth and comfort to your outdoor area for many years.

Prior to installation and operation ensure that all specifications, dimensions, and minimum clearances stated in this manual are observed. You must read all warnings and safety information, and understand all of the information in this manual. All installation requirements must be observed and met.

PRE-INSTALLATION AND PREPARATION SAFETY GUIDELINES

- A. A shut-off valve (not included) in the gas line is required.** It provides for safety when the unit is not in use and for convenient maintenance and repair. It must be installed within 6 feet of unit. Use a pipe joint compound resistant to all gasses on all male fittings except flare fittings.
- B.** Before installing this unit, check the MINIMUM CLEARANCES section to ensure that the surrounding area is **properly sized for the installation.**
- C.** The unit is for outdoor use only. **DO NOT** install or use this appliance inside a building, garage, or any other enclosed area, including recreational vehicles and/or boats. **THIS UNIT MUST BE INSTALLED SO THAT THE VENT OPENINGS AND SURROUNDING AREA OF THE UNIT REMAIN CLEAR AND FREE AT ALL TIMES.**
- D. SOLID FUEL MUST NOT BE BURNED in the unit.**
- E. CHECK GAS TYPE** (natural gas or propane): The gas supply you intend to use may not be the same as that stated on the unit rating plate as purchased. If the gas supply is different, **convert the unit to the gas type you intend to use (IF PERMITTED).** See the FUEL CONVERSION KIT section and contact the dealer for assistance.
- F. FOR NATURAL GAS:** The minimum inlet gas-supply pressure for purposes of input adjustment is **5"** water column (w.c.), and the maximum inlet gas-supply pressure is **10.5"** w.c.
FOR PROPANE GAS: The minimum inlet gas-supply pressure for purposes of input adjustment is **11"** w.c., and the maximum inlet gas-supply pressure is **13"** w.c. **DO NOT INSTALL THIS UNIT IF MINIMUM PRESSURE IS NOT AVAILABLE OR IF MAXIMUM PRESSURE IS EXCEEDED.**
- G. The gas piping system must be sized to provide minimum inlet pressure at the maximum flow rate (BTU/hr).** Undue pressure loss will occur if the pipe is too small, or the run is too long. Gas supply pipe must be 1/2" minimum interior diameter. If the gas line is longer than 20', a larger diameter line may be necessary. Refer to the NFPA 54 guidelines for further details.
- H.** For installations at elevations above 2,000 ft., contact your local dealer or gas supplier before installing. Input ratings should be reduced approximately 4% per 1,000 ft. above sea level. Refer to National Fuel Gas Code.
- I.** The unit and its individual shut-off valve must be disconnected from the gas-supply piping system during any pressure testing of that system at test pressures in excess of 1/2 psi (3.5 kPa). This is accomplished by closing the gas-supply line valve. The unit must be isolated from the gas-supply piping system by closing its individual manual shut-off valve during any pressure testing of the gas-supply piping system at test pressures equal to or less than 1/2 psi (3.5 kPa).
- J.** When an appliance is for connection to a fixed piping system, the installation must conform with local codes, or in the absence of local codes with the National Fuel Gas Code, ANSI Z223.1/NFPA 54; International Fuel Gas Code, Natural Gas and Propane Installation Code, CSA B149.1; or Propane Storage and Handling Code, B149.2, as applicable. The appliance, when installed, must be electrically grounded in accordance with local codes, or in the absence of local codes with the National Electrical Code, ANSI/NFPA 70; or the Canadian Electrical Code, CSA C22.1, if applicable.

Electrical Grounding Instructions (if applicable) - Select models are equipped with a three-prong (grounding) plug for your protection against shock hazard and should be plugged directly into a properly grounded three-prong receptacle. Do not cut or remove the grounding prong from this plug.

- K. INSTALLER NOTE:** This unit should be installed so that it can be removed if service is required.

L. GAS-SUPPLY PLUMBING REQUIREMENTS

Apply only joint compounds that are resistant to all gasses on all male pipe fittings. Make sure to tighten every joint securely. Do not use pipe joint compound to connect flare fittings. Bring the gas-supply pipe up from beneath the enclosure near its center (if applicable).

- M. DECORATIVE MEDIA:** The included lava granules, and additional primary decorative media (not included), are required for safe operation and proper performance. You MUST purchase the additional primary media separately. Numerous options are available. See the SPECIFICATIONS AND DIMENSIONS (media option) section for details.

CAUTION: Installation and maintenance must be done by an NFI Certified or other qualified professional service technician. Installer, read these instructions before installing this product. Be sure you understand all safety precautions and warnings contained in this manual.

INSTALLATION SAFETY GUIDELINES

- A. Carefully inspect for shipping damage. If any parts are damaged, contact your dealer.
- B. Installation and repair should be done by a qualified professional service technician. The appliance should be inspected before use and at least annually by a qualified service person. More frequent cleaning may be required as necessary. It is imperative that control compartment, burners and circulating air passageways of the appliance are kept clean.
- C. **WEAR GLOVES AND USE EXTREME CAUTION WHENEVER INSTALLING AND HANDLING THIS PRODUCT AND ITS ACCESSORIES AS CERTAIN COMPONENTS HAVE SHARP EDGES THAT CAN CAUSE PERSONAL INJURY.**
- D. Correct installation and proper placement of the unit and decorative media **is crucial** to the safe performance of the unit. See MEDIA PLACEMENT section for details.
- E. **DO NOT** install the unit under any overhead construction.
- F. Ensure that the unit is installed on a hard and level surface.
- G. **This unit must be installed so that the vent openings and surrounding area of the unit remain clear and free at all times.**
- H. Due to high temperatures, the unit must be located out of traffic areas and away from combustibles.
- I. **IF APPLICABLE, KEEP THE PILOT/IGNITER SCREEN CLEAR OF DECORATIVE MEDIA AND ANY OTHER ITEMS / DEBRIS AT ALL TIMES. THIS WILL ALLOW FOR PROPER IGNITION AND OPERATION. DO NOT COVER.**

OPERATING THE UNIT SAFELY AND CORRECTLY

- A. **This product is a decorative gas appliance. It is not a cooking appliance.**
- B. **SOLID FUEL MUST NOT BE BURNED in the unit.**
- C. When shutting the unit down—be sure to TURN THE CONTROL VALVE FULLY OFF.
- D. Children MUST be supervised when they are in the area of this appliance.
- E. **DO NOT** sit or place any part of the body, clothing, or other flammable materials on or near the unit surround. Children and adults should be alerted to the hazard of high surface temperatures and should stay away to avoid burns or clothing ignition. **DO NOT** lean over the unit when lighting or when in use.
- F. Every time you use the unit, **make sure that:**
 - 1. The area around the unit is clear and free from combustible materials, gasoline and other flammable vapors and liquids.
 - 2. The vent openings and surrounding area of the unit are clear and free at all times.
 - 3. **THE PILOT/IGNITER SCREEN IS CLEAR OF DECORATIVE MEDIA AND ANY OTHER ITEMS / DEBRIS (IF APPLICABLE). DO NOT COVER.**
 - 4. The hose is inspected (if applicable). See the SAFE USE & MAINTENANCE OF PROPANE-GAS CYLINDERS section.
- G. **WARNING: HOT WHILE IN OPERATION AND FOLLOWING OPERATION. Serious injury can occur! DO NOT** throw trash, paper, or other flammable materials onto the unit. **DO NOT** leave in operation when unattended.
WARNING: DO NOT operate this unit in the rain.
WARNING: DO NOT operate this unit in high-wind conditions. Operating in high-wind conditions may expose your unit to direct flame, which will result in cracking and discoloration to the finish.
- H. **DO NOT** continue using if you smell unusual odors, or have headaches, nausea, or dizziness.
- I. **DO NOT** store any combustible materials, gasoline, and any other flammable vapors/liquids in the vicinity of the unit. Provide adequate clearance for servicing and operation.
- J. Matches, paper, garbage, or any other material must not be thrown onto the unit or into the flame.
- K. **DO NOT** use the unit if any part of it has been underwater. Immediately call a qualified professional service technician to inspect the unit and to replace any part of the control system and any gas control that has been underwater.

UTILISATION SÛRE ET ENTRETIEN DES CYLINDRES DE GAZ DE PROPANE

IMPORTANT POUR VOTRE SÛRETÉ

LISEZ ET SUIVEZ TOUS LES AVERTISSEMENTS ÉQUIPÉS DE VOTRE CYLINDRE DE GAZ DE PROPANE.

En actionnant cet appareil avec un cylindre de gaz de propane ON DOIT observer ces instructions et avertissements.

LE MANQUE DE FAIRE AINSI PEUT AVOIR COMME CONSÉQUENCE UNE INCENDIE OU UNE EXPLOSION SÉRIEUSE.

CYLINDRE ET CONDITIONS ET

CARACTÉRISTIQUES DE CONNECTEUR

- Des cylindres et les valves de gaz de propane doivent être maintenus en bon état et doivent être remplacés s'il y a des dommages évidents au cylindre ou à la valve.
- Ce gril, une fois utilisé avec un cylindre, devrait être relié à un gallon de la norme 5 (20lb.) cylindre de gaz de propane équipé d'un OPD (remplissez au-dessus du niveau le dispositif d'empêchement). L'OPD a été exigé sur tous les cylindres vendus depuis octobre 1.1998 pour empêcher le remplissage excessif.
- Les dimensions de cylindre devraient être approximativement 12" (30.5cm) de diamètre et 18" (45.7cm) hauts. Des cylindres doivent être construits et marqués selon les caractéristiques pour des cylindres de gaz de propane du département des ETATS-UNIS du transport (D.O.T.) ou le niveau national du Canada, du CAN/CSA-B339, des cylindres, des sphères et des tubes pour le transport des marchandises dangereuses.
- Le cylindre doit inclure un collier pour protéger la valve de cylindre et le circuit d'alimentation de cylindre doit être assuré le retrait de vapeur.
- Le régulateur de pression et l'ensemble de tuyau utilisé doivent assortir les spécifications pour le type I par ANSI Z 21.58/CGA 1.6 (voir la figue. 6-1).
- La valve de cylindre de gaz de propane doit être équipée d'un dispositif d'accouplement de raccordement de cylindre, décrit comme type I dans la norme définie dans le e. de paragraphe ci-dessus. Ce dispositif est généralement décrit comme coupleur rapide de fil de point culminant.
- Si votre cylindre de gaz de propane vient avec une prise de la poussière, placez le bouchon anti-poussière sur la sortie de valve de cylindre toutes les fois que le cylindre n'est pas en service.

OPÉRATION DE COUPLEUR RAPIDE

Pour relier le regulator/hose à l'ajustage de précision de valve de cylindre de gaz de propane: Serrez l'écrou de main sur le régulateur au-dessus de l'ajustage de précision de fil de point culminant sur la valve de cylindre. Tournez l'écrou de

main dans le sens des aiguilles d'une montre pour engager les fils et pour serrer jusqu'à ce que douillettement. L'utilisation des pinces ou de la clé ne devrait pas être nécessaire. Seulement le propane marqué par cylindres doit être employé.

Pour débrancher: Tournez l'écrou de main dans le sens contraire des aiguilles d'une montre jusqu'à isolé (fig. 6-1).

Important: Avant d'employer le gril, et ensuite chaque fois que le cylindre est enlevé et rattaché, examinez tous les raccordements pour déceler les fuites. Arrêtez les valves de gril et ouvrez la valve principale de cylindre, puis vérifiez les raccordements avec de l'eau savonneux. Réparez toutes les fuites avant d'allumer le gril.

ATTENTION: Tournez toujours la valve principale de cylindre de propane au loin après chaque utilisation, et avant de déplacer le gril et le cylindre, ou débrancher l'accouplement. Cette valve doit rester fermée et le cylindre a débranché alors que l'appareil n'est pas en service, quoique l'écoulement de gaz soit arrêté par un dispositif de sûreté quand le coupleur est débranché.

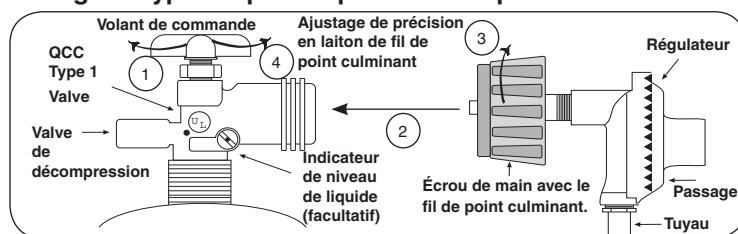
Inspectez soigneusement l'ensemble de tuyau chaque fois avant que le gaz soit allumé. Un tuyau fissuré ou effiloché doit être immédiatement remplacé.

Si l'appareil est stocké à l'intérieur, le cylindre doit être disconnected et a enlevé. Des cylindres Disconnected doivent être stockés dehors, hors de la portée des enfants, avec les prises de valve filettées étroitement installées, et ne doivent pas être stockés dans un bâtiment, le garage, ou n'importe quel autre secteur inclus.

POUR VOTRE SÛRETÉ

- Ne stockez pas un cylindre de gaz disponible de propane dessous ou ne vous approchez pas de cet appareil.

SAFE USE & MAINTENANCE OF PROPANE GAS CYLINDERS

IMPORTANT FOR YOUR SAFETY

READ AND FOLLOW ALL WARNINGS PROVIDED WITH THE PROPANE-GAS CYLINDER.

When operating this appliance with a propane-gas cylinder, these instructions and warnings **MUST** be observed.

FAILURE TO DO SO MAY RESULT IN A SERIOUS FIRE OR EXPLOSION.

CYLINDER/CONNECTOR REQUIREMENTS

- a. Propane-gas cylinders, valves, and hoses must be maintained in good condition and must be replaced if there is visible damage to either the cylinder or valve. If the hose is cut or shows excessive abrasion or wear, it must be replaced before using the gas appliance (see e.).
- b. This unit, when used with a cylinder, should be connected to a standard 5-gallon (20 lb.) propane-gas cylinder equipped with an OPD (Overfill Prevention Device). The OPD has been required on all cylinders sold since October 1, 1998, to prevent overfilling.
- c. Cylinder dimensions should be approximately 12" (30.5 cm) in diameter and 18" (45.7 cm) high. Cylinders must be constructed and marked in accordance with the *Specifications for Propane Gas Cylinders of the U.S. Department of Transportation (D.O.T.)* or the National Standard of Canada, *CAN/CSA-B339, Cylinders, Spheres, and Tubes for Transportation of Dangerous Goods*.
- d. The cylinder used must include a collar to protect the cylinder valve, and the cylinder supply system must be arranged for vapor withdrawal.
- e. The pressure regulator and hose assembly used must match the specification for Type I by *ANSI Z 21.58/CGA 1.6* (see Fig. 7-1).
- f. The propane-gas cylinder valve must be equipped with a cylinder connection coupling device, described as Type I in the standard defined in paragraph e. above. This device is commonly described as an Acme thread quick coupler.
- g. If the propane-gas cylinder comes with a dust plug, place the dust cap on the cylinder valve outlet whenever the cylinder is not in use.

QUICK COUPLER OPERATION

To connect the regulator/hose assembly to the propane-gas cylinder valve fitting: Press the hand nut on the regulator over the Acme thread fitting on the cylinder valve. Turn the hand nut clockwise to engage the threads and tighten until snug.

The use of pliers or a wrench should not be necessary. Only cylinders marked "propane" may be used.

To disconnect: Turn the hand nut counterclockwise until detached (Fig. 7-1).

Important: Before using the unit, and after each time the cylinder is removed and reattached, check the hose for wear (see a.) and check all connections for leaks. Turn off the unit valves and open the main cylinder valve, then check connections with soapy water. Repair any leaks before lighting the unit.

CAUTION: Always turn the propane cylinder main valve off after each use, and before moving the unit and cylinder or disconnecting the coupling. This valve must remain closed and the cylinder disconnected while the appliance is not in use, even though the gas flow is stopped by a safety feature when the coupler is disconnected.

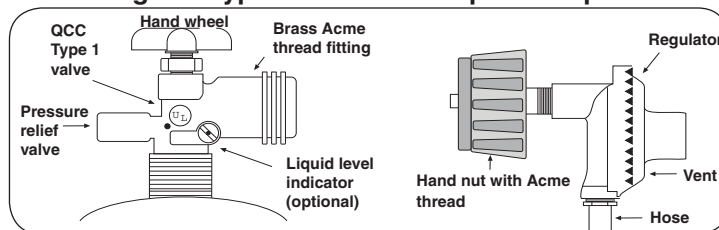
Carefully inspect the hose assembly each time before the gas is turned on. A cracked or frayed hose must be replaced immediately.

If the appliance is stored indoors, the cylinder must be disconnected and removed. Disconnected cylinders must be stored outdoors, out of the reach of children, with threaded valve plugs tightly installed, and must not be stored in a building, garage, or any other enclosed area.

FOR YOUR SAFETY

- a. DO NOT store a spare propane-gas cylinder under or near this appliance.
- b. NEVER fill the cylinder beyond 80-percent full.
- c. IF THE INFORMATION IN a. AND b. IS NOT FOLLOWED EXACTLY, A FIRE CAUSING DEATH OR SERIOUS INJURY MAY OCCUR.

Fig. 7-1 Type I Acme thread quick coupler



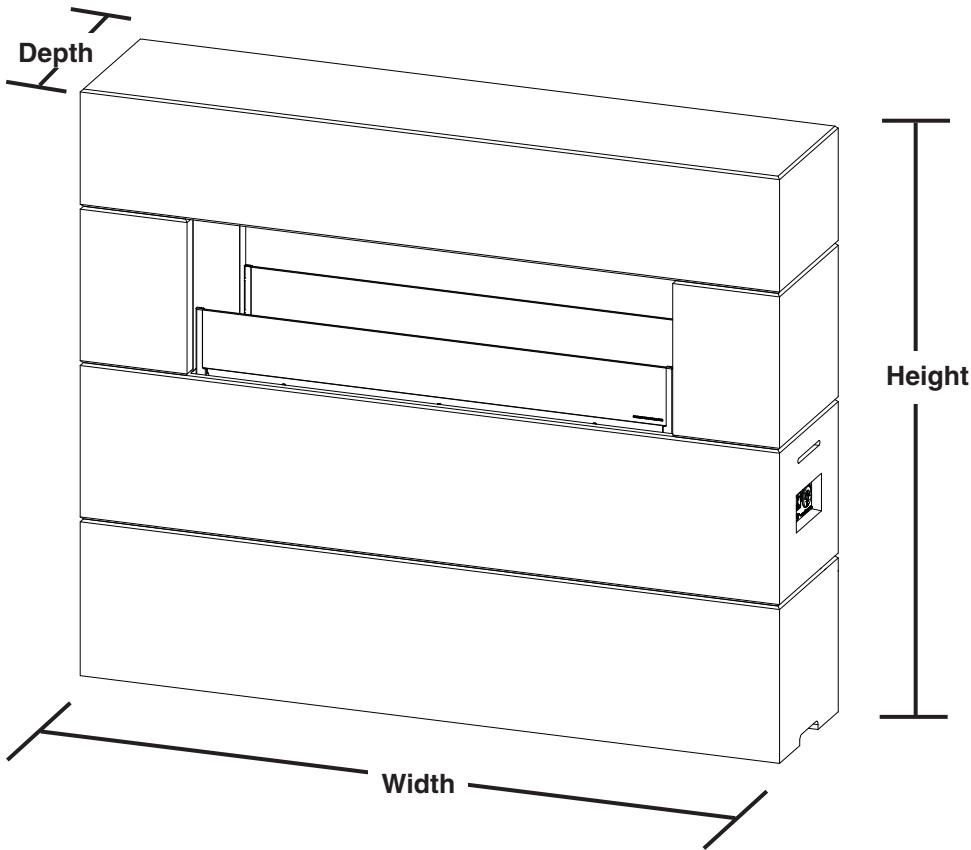

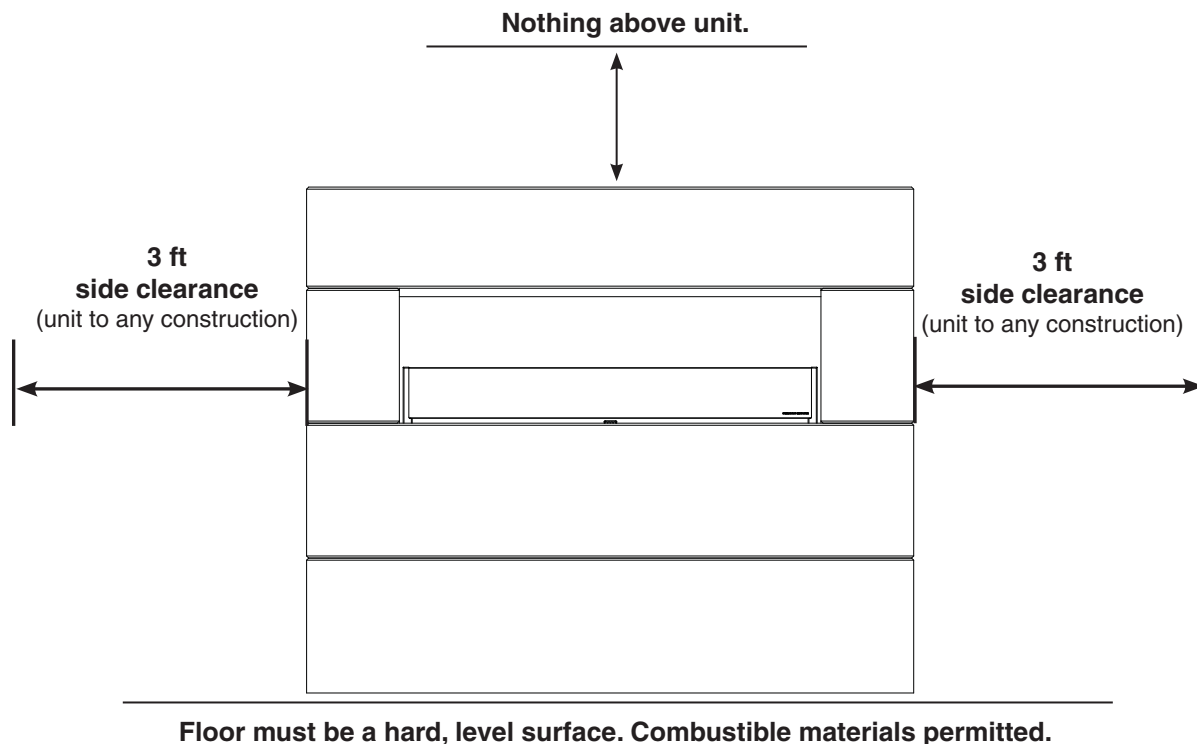

FIREPLACE INSTALLATION

BEFORE YOU BEGIN

Important: Prior to installation ensure that all specifications, dimensions, and minimum clearances stated in this manual are observed. You must read all warnings and safety information, and understand all of the information in this manual. **All installation requirements must be observed and met.**

WARNING: Failure to position the parts in accordance with these diagrams or failure to use only parts specifically approved with this appliance may result in property damage or personal injury.

- Confirm the installation site accommodates the unit per the requirements in this manual.
- Be sure the gas supply (propane or natural) is turned off at its source.
- Remove all packing material (including any protective coatings) and discard prior to installation.

LOCATION

While following all requirements and safety information in this manual (see MINIMUM CLEARANCES section); determine and prepare the location of the unit (a hard and level surface).

Note: For fireplace, a combustible surface is permitted.

Important: The gas supply and electrical setup must be considered when determining the location of the unit. See GAS SUPPLY SETUP and ELECTRICAL SETUP section for details (as applicable).

ASSEMBLY REQUIRES TWO OR MORE PEOPLE.

EXERCISE EXTREME CARE DURING ASSEMBLY AND INSTALLATION.

GAS SUPPLY SETUP (if applicable)

For Natural or Household Propane Gas Supply:

The gas supply is to be brought up from beneath the unit near its center. Your individual installation may vary. **Observe the National Fuel Gas Code and all local codes.**

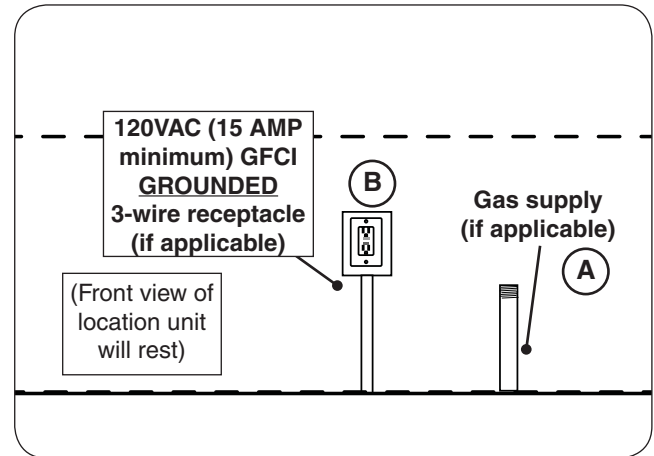


Fig. 16-1 Route gas and electrical (as applicable)

1. Route the gas supply into the area that the unit will rest over (see Fig. 16-1, A).

Note: The gas supply or another flex can also be routed through the side of the unit (through a ventilation opening at the floor).

Important: Locate the gas supply line out of pathways where people may trip over it or in areas where the line may be subject to accidental damage (if applicable).

Note: A shut-off valve (not included) in the gas line is required. It must be installed within 6 feet of unit. Use a pipe joint compound resistant to all gasses on all male fittings except flare fittings.

ELECTRICAL SETUP

A **120VAC (15 AMP minimum) GFCI GROUNDED 3-wire receptacle** (not included) is required within the vicinity of the fireplace to provide power to the unit. The GFCI receptacle must be a WEATHER-PROOF IN-USE COVERED RECEPTACLE. The unit's power supply cord is located on the rear of the valve box. Your individual installation may vary. **Observe the National Electric Code and all local codes.**

1. Wire the receptacle into the area that the unit will rest over (see Fig 16-1, B).
 - **Verify proper polarity of the receptacle.**
 - **If an extension cord is used, ensure it is a 3-wire GROUNDED cord that is rated for the power of the equipment, and is approved for outdoor use with a W-A marking. DO NOT use 2-prong adapters.**
 - **DO NOT TAMPER WITH THE EXTENSION CORD OR THE UNIT POWER-SUPPLY CORD.**

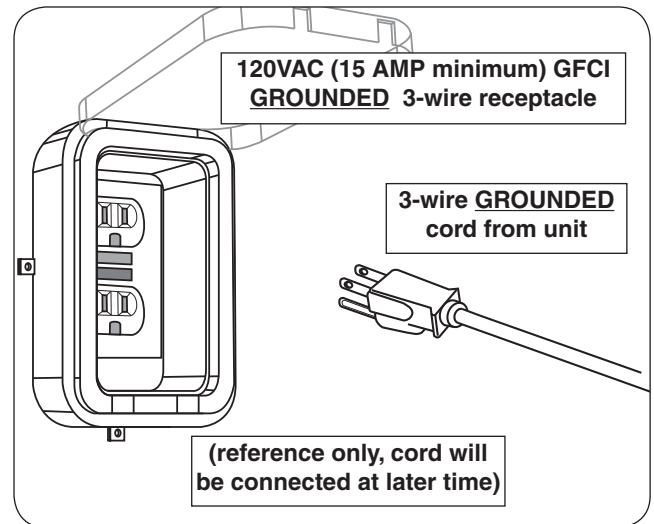


Fig. 16-2 Electrical setup detail

PLACE BASE AND REMOVE BURNER

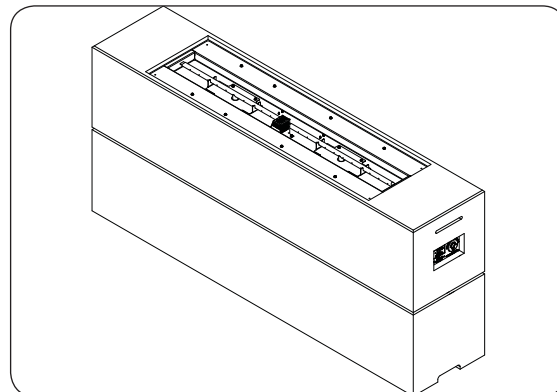


Fig. 17-1 Place base

1. **CAREFULLY** place the base in an appropriate location (see Fig. 17-1, and refer back to the LOCATION section if needed).

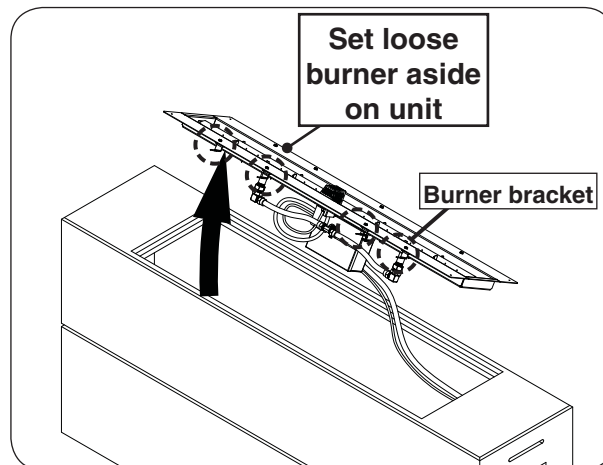


Fig. 17-2 Remove burner assembly

2. Use a $\frac{5}{16}$ " nut driver to partially unfasten the eight screws found on the burner assembly. Then carefully remove the burner and set it off to the side. See Fig. 17-2.

Note: **DO NOT** completely remove the screws - to ensure the burner brackets (beneath) remain assembled.

Remove with care to prevent damage to the electrical and gas connections.

ASSEMBLE BASE

The base is made up of two pieces. It is pre-assembled at the manufacturer. Ensure the assembly is properly fastened by reviewing the assembly procedure:

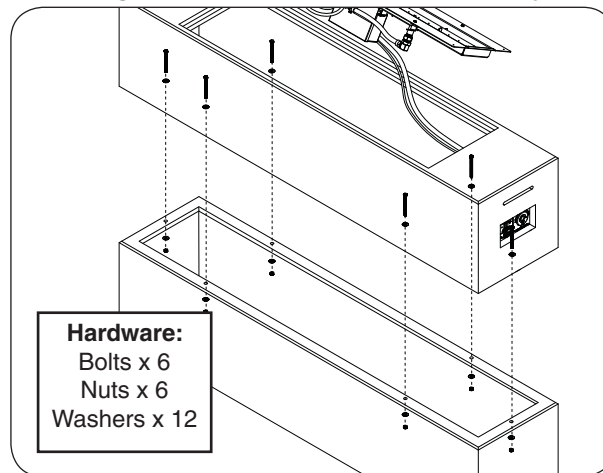


Fig. 17-3 Verify proper base assembly

1. Align the top piece over the bottom piece. Insert the hardware kits in the order shown in Fig. 17-3. Hand tighten, then use two $\frac{1}{2}$ " open end wrenches (or equivalent) to fasten.

MOUNT BASE

CAUTION: The base **MUST** be mounted to the installation site floor. Failure to do so can cause property damage, personal injury, and/or damage to the unit.

1. Using appropriate mounting hardware for the floor material/construction, secure the base into the floor. The interior of the base has four $\frac{1}{2}$ " holes that will allow for the base to be fastened to the floor. See Fig. 19-4.

Important: **DO NOT** overtighten (to avoid damage to the unit).

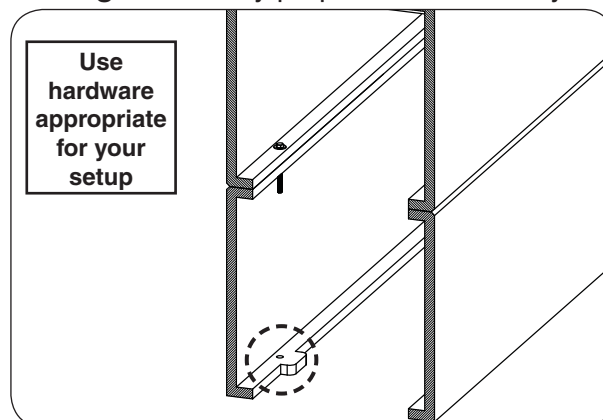


Fig. 17-4 Mount base to floor

CONNECT GAS SUPPLY

Important: Before installation, be sure the gas supply (propane or natural) is turned off at its source.

Your unit is equipped with a flex connector that is to be routed to a gas supply appropriate for your setup. Additional gas components may be required. Consult a qualified professional service technician, and your local dealer. Follow the guidelines below.

To Connect To a Propane Cylinder:

1. The unit does not accommodate propane cylinders. A cylinder must be located in a safe location, within reach of the unit connections. Observe the National Fuel Gas Code and all local codes. An appropriate hose assembly must be purchased separately. **A 2-stage regulator hose assembly (min. BTU capacity 150k) is required.**

Tank tables and propane extension hoses are available from American Fyre Designs. Contact your local dealer for ordering information.

2. Connect the hose assembly (not included) to the flex connector (marked IN) that is coming off the valve assembly.

Note: Your individual installation may vary. Apply only joint compounds that are resistant to all gasses on all male pipe fittings. Make sure to tighten every joint securely. Do not use pipe joint compound to connect flare fittings.

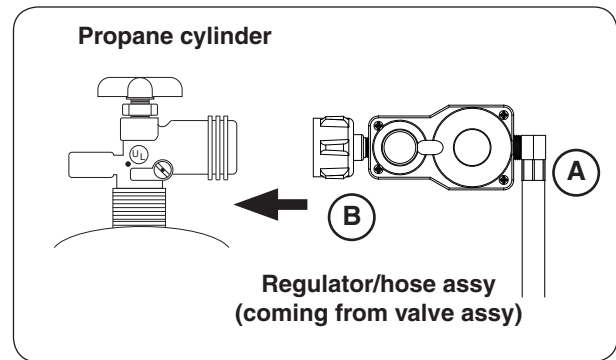


Fig. 18-1 Connecting to an L.P. cylinder

3. Attach the regulator end of the hose assembly to a propane cylinder (not included) and tighten (see Fig. 18-1).

To Connect To a Natural or Household Propane Gas Supply:

1. Locate the flex connector (marked IN) that is coming off the valve assembly.
2. Locate the gas supply that is beneath or beside the unit (previously routed at beginning of installation).
3. A shut-off valve is required within 6 feet of the unit.

If shut-off valve is connected to end of gas supply stub:

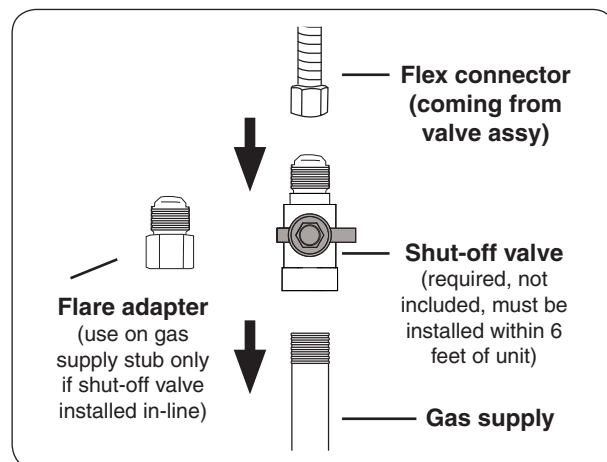


Fig. 19-1 Connecting to a gas line

- Connect the flex connector to the shut-off valve (see Fig. 19-1). Tighten securely.

If shut-off valve is installed in-line:

- Install the supplied flare adapter to the gas supply using a pipe joint compound resistant to all gasses (see Fig. 19-1). Tighten securely.
- Connect the flex connector to the flare adapter (see Fig. 19-1). Tighten securely.

LEAK TEST

Turn on the gas supply and test at all connections for leaks using a soapy water solution. If bubbles appear, a leak is present. Turn off the gas and tighten at all connections. Repeat until no leaks are present. If a leak persists, turn off the gas supply and contact the local gas company or dealer. **NEVER USE A FLAME TO CHECK FOR LEAKS.**

CONNECT POWER SUPPLY CORD

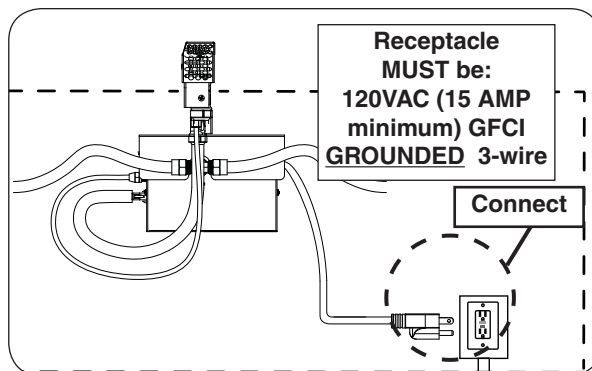


Fig. 20-1 Route and connect power supply cord

Route the power supply cord (coming from valve box) to the previously wired **120VAC (15 AMP minimum) GFCI GROUNDED 3-wire receptacle** and connect (see Fig. 20-1).

REINSTALL BURNER ASSEMBLY

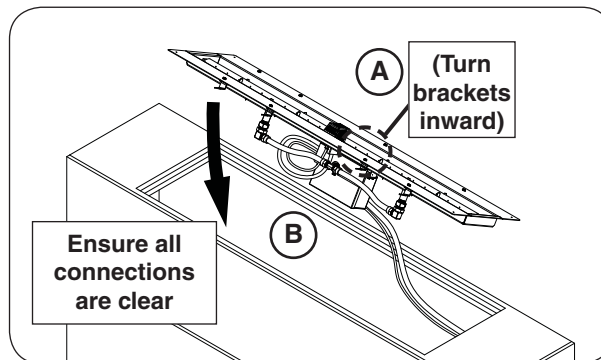


Fig. 20-2 Insert burner assembly

1. Ensure that the eight burner brackets are turned inward, then insert the burner assembly (see Fig. 20-2, A-B).

Important: Ensure the electrical and gas connections are clear, undamaged, and completely inserted into the opening. DO NOT pinch the wires.

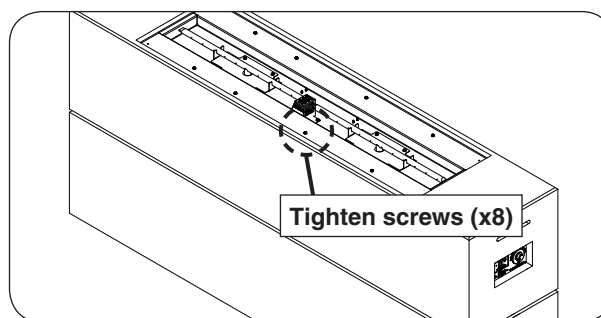


Fig. 20-3 Install burner

2. Use a $\frac{5}{16}$ " nut driver to fasten the burner to the base (see Fig. 20-3).

INSTALL BATTERIES

At this stage the burner system batteries are to be installed. Reference the **SERVICING AND CLEANING - BATTERY INSTALLATION/REPLACEMENT** section for details.

LIGHTING TEST

Prior to proceeding with installation, perform a lighting test (see lighting instructions for lighting your burner). **Allow the unit to completely cool after testing.**

ASSEMBLE BODY

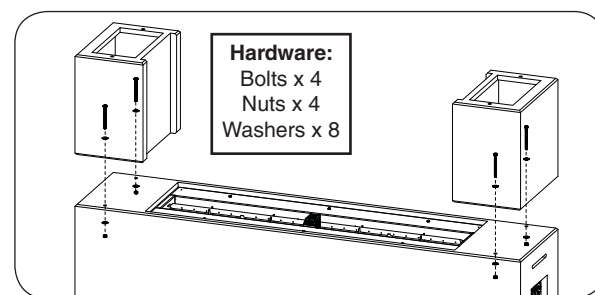


Fig. 20-4 Assemble side pieces

1. Place a side piece on top of the base. Carefully align the pilot holes, and insert the hardware in the order shown in Fig. 20-4. Hand tighten, then use two $\frac{3}{4}$ " open end wrenches (or equivalent) to fasten. Repeat for the other side.

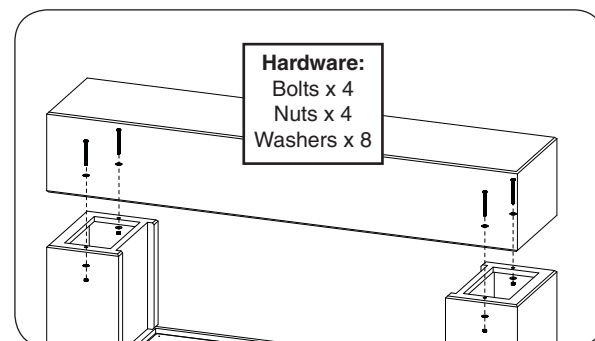


Fig. 20-5 Assemble top piece

2. Place the top piece on top of the side pieces. Carefully align the pilot holes, and repeat the hardware installation process. See Fig 20-5.

LINERS

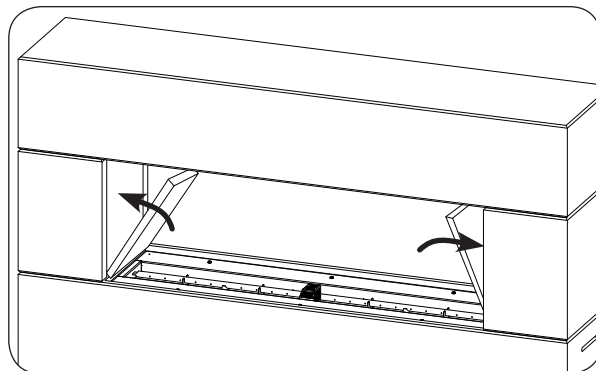


Fig. 21-1 Install side liners

1. Install a side liner into the interior of the firebox. See Fig. 21-1. Use masking tape to temporarily hold the liner in place. Repeat for the other side.

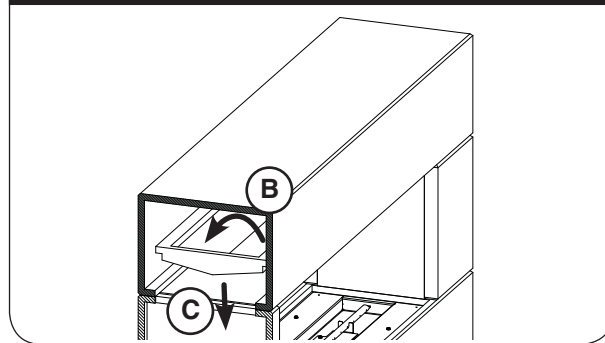
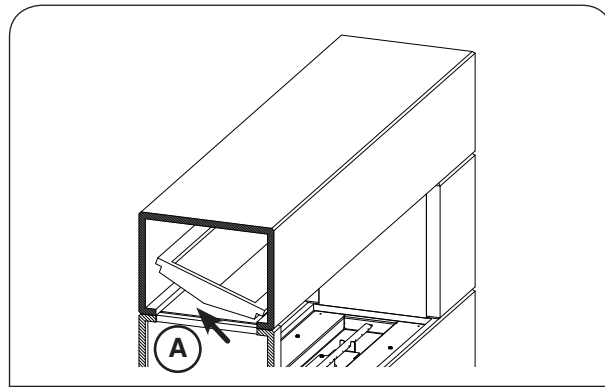


Fig. 21-2 Install top liner

2. Install the top liner at an angle as shown in Fig. 21-2, A. Then tilt flat and lower into place as shown in Fig. 21-2, B-C.
3. Remove the tape from the side liners.

Note: The liners rest in place. No hardware is required.

INSTALL WIND GUARD

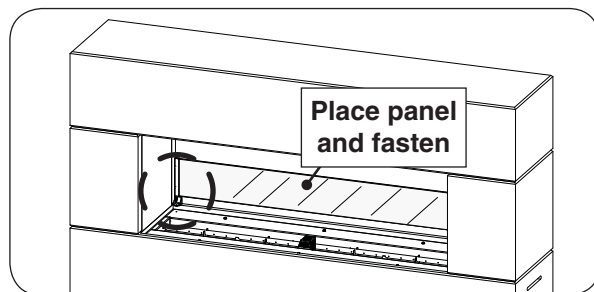


Fig. 21-3 Place wind guard

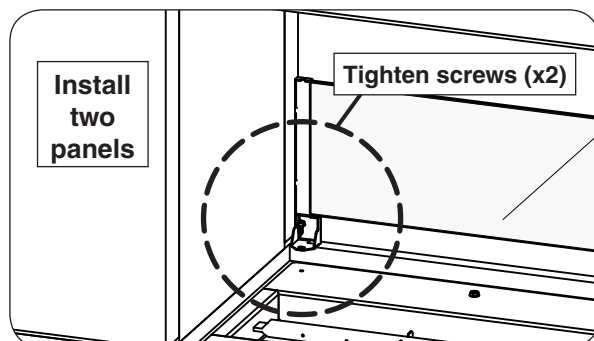


Fig. 21-4 Install screws

1. Place one of the wind guard panels into the burner area, ensuring that it is centered. While holding, use a $\frac{5}{16}$ " nut driver and two of the supplied screws to fasten the panel in place. See Fig. 21-3 and Fig. 21-4.

Important: Start both screws to ensure the panel is properly aligned, then fasten the screws.

2. Repeat for the second panel.

DECORATIVE MEDIA PLACEMENT

WARNING: Failure to position the parts in accordance with these diagrams or failure to use only parts specifically approved with this appliance may result in property damage or personal injury.

CAUTION: Be sure the unit and the decorative media are completely cool anytime the media is handled. **Wear gloves** whenever installing and handling as certain media may have sharp edges that can cause personal injury.

Important: Keep the pilot screen clear of decorative media and any other items / debris at all times. This will allow for proper ignition and operation. **DO NOT** cover.

REQUIRED BASE MEDIA (SUPPLIED)

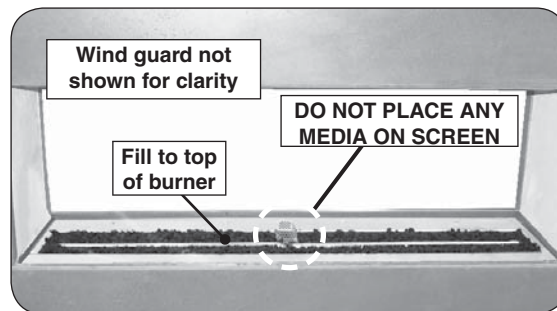


Fig. 22-1 Lava media option

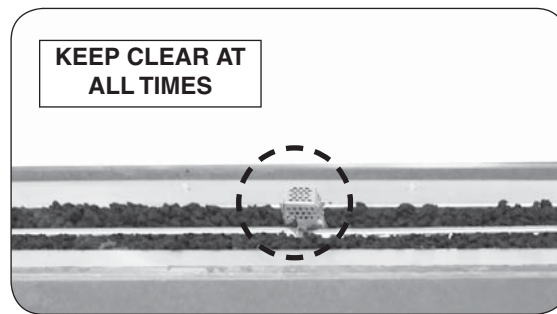


Fig. 22-2 Screen detail

1. Pour the 10 lb bag of lava granules into the burner area (with the exception of the screen). Spread the granules within the burner area as shown in Fig. 22-1 and Fig. 22-2. **Only fill the granules up to the top of the burner tube.**
2. Proceed to the following section to complete media placement.

PRIMARY AND SECONDARY MEDIA OPTIONS

Additional decorative media **MUST** then be placed to cover the burner. The decorative media is purchased and packaged separately. Contact your local American Fyre Designs dealer for ordering information. Locate the following section(s) that apply to your option(s) chosen and install accordingly.

The included lava granules, and one of the primary media options (lava or glass) are required for safe operation and proper performance. Place first. All other media is optional.

Reference the SPECIFICATIONS AND DIMENSIONS section for details on the recommended amounts of media.

Lava Media

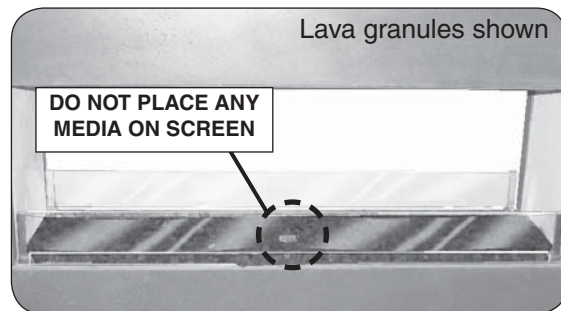


Fig. 23-1 Lava media option

After the required base lava granules have been placed, pour the additional lava granules or lava coals evenly into the burner area (with the exception of the screen). The lava should be 1-2" above the burner. See Fig. 23-1.

Important: DO NOT exceed a height of 2" above the burner when placing lava media. Ensure no media covers the screen. Store any excess media in a safe location.

Volcanic Stones

1. Volcanic stones first require lava media to completely fill the burner area. See previous REQUIRED BASE MEDIA and LAVA MEDIA sections to place the lava, then proceed to step 2.

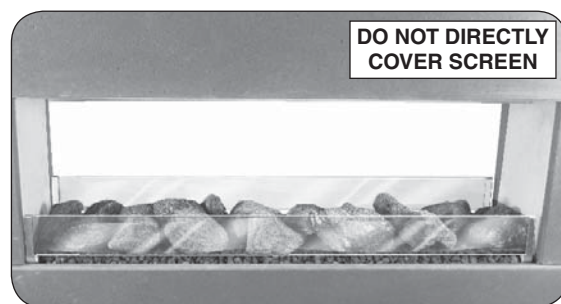


Fig. 23-2 Volcanic stones option

2. Pour the volcanic stones evenly into the burner area (see Fig. 23-2). Store any excess media in a safe location.

Glass Media

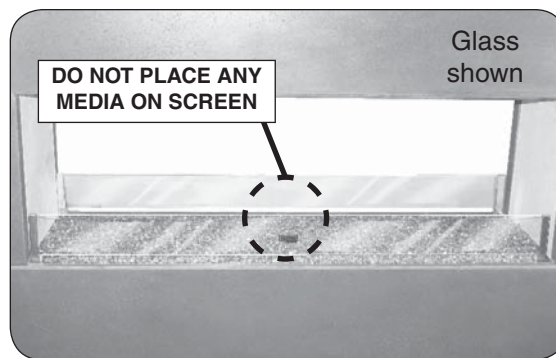


Fig. 24-1 Glass option

After the required base **lava granules** have been placed, pour the glass media (glass, gems) evenly into the burner area (see Fig. 24-1). The glass should be 1-2" above the burner.

Important: **DO NOT** place any glass media on the screen. Ensure no existing lava granules are covering the screen.

DO NOT exceed a height of 2" above the burner when placing glass media. Store any excess media in a safe location.

Additional Secondary Options

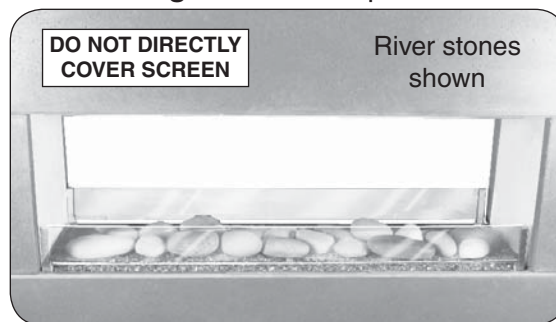


Fig. 24-2 Secondary options

After the required base lava granules and additional lava or glass media have been placed, various river stone, creekstone, geo shape, log, wood chunk, and glass nugget options are available. If one of these secondary options are purchased, place them as desired in a decorative pattern on top of the primary media. See Fig. 24-2 for an example.

Note: These options are not designed to be placed directly on the burner.

OPTIONAL FABRIC COVER

An optional fabric cover is available to protect your unit when not in use. Contact your local dealer for ordering information.

To install, allow the unit to cool completely, open the zipper on the cover, then place the cover over the unit with the American Fyre Designs logo facing forward. Close the zipper on the cover. See Fig. 25-1.

Follow all instructions provided with the fabric cover.

LIGHTING INSTRUCTIONS - ALL WEATHER REMOTE MODELS

FOR YOUR SAFETY, READ BEFORE LIGHTING

WARNING: If you do not follow these instructions exactly, a fire or explosion may result causing property damage, personal injury or loss of life.

- A. This appliance is equipped with an ignition device that automatically lights the pilot. DO NOT attempt to light the pilot by hand.
- B. **BEFORE LIGHTING**, smell all around the unit area for gas. Be sure to smell next to the floor, because some gas is heavier than air and will settle on the floor.
- C. **WHAT TO DO IF YOU SMELL GAS**
 1. Shut off the gas to the appliance.
 2. Extinguish any open flame.
 3. If odor continues, immediately call your gas supplier or the fire department.
- D. Use only your hand to push in or move the controls. Never use tools. If the control will not push in or move by hand, **DO NOT** try to repair it. Call a qualified professional service technician. Force or attempted repair may result in fire or explosion.

REMOTE LIGHTING

CAUTION: DO NOT attempt to light the pilot by hand.

Note: If the remote does not function, and batteries with an adequate power level are installed, refer to the SYNCING THE REMOTE section.

Note: Steps 1-2 may not be required if previously done during an earlier lighting.

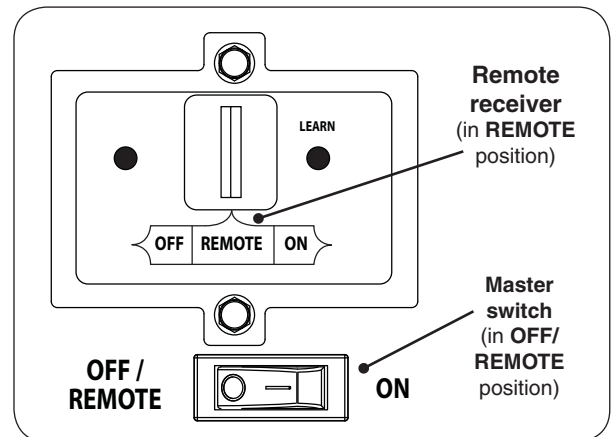


Fig. 27-1 Control panel detail

1. Ensure the master switch is in the **OFF/REMOTE** position (see Fig. 27-1).
2. Locate the 3-position switch on the remote receiver (see Fig. 27-1), and slide the switch to the **REMOTE** position.

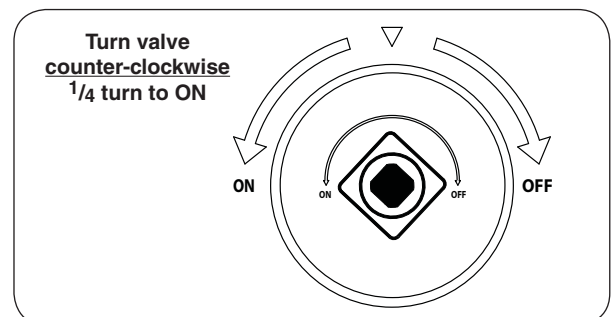


Fig. 27-2 ON/OFF key valve detail

3. Turn the ON/OFF key valve counter-clockwise a $\frac{1}{4}$ turn to the **ON** position (Fig. 27-2).

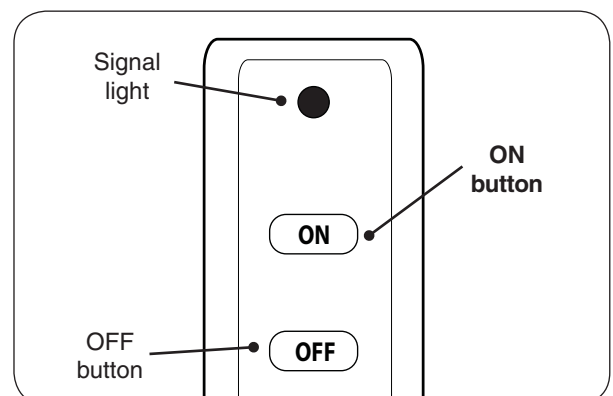


Fig. 27-3 Remote transmitter detail

4. Locate the remote transmitter and press the **ON** button (see Fig. 27-3). The ignition sequence will begin.

The remote receiver will emit an audible "beep"; then the ignition sequence will begin. After the pilot lights and is established, the valve will automatically open and the burner will light.

Note: The ignition sequence will take approximately 10 seconds.

WARNING: If the burner fails to light within 10 seconds, press the **OFF** button on the remote transmitter and/or slide the remote receiver switch to the **OFF** position. Allow five (5) minutes for any gas in the unit to dissipate, then repeat steps 1-4 above. **IF YOU SMELL GAS, SEE STEP B ABOVE.**

If the pilot fails to light after several tries, turn all control/remote system components to **OFF** and refer to the TROUBLESHOOTING section for further details.

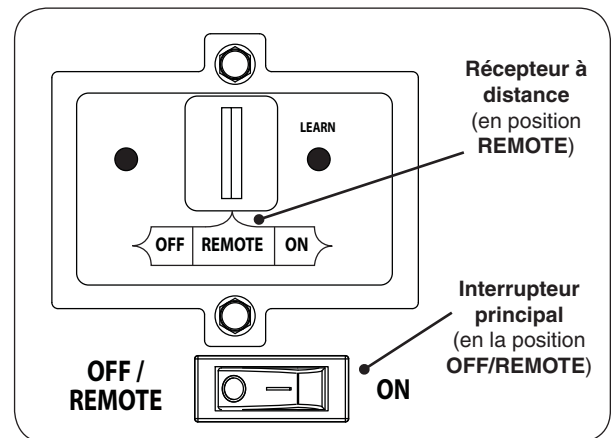


Fig. 28-1 Contrôle détail du panneau

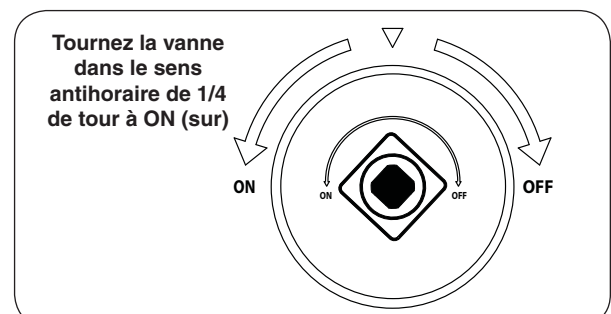


Fig. 28-2 SUR/ÉTEINDRE vanne clé détail

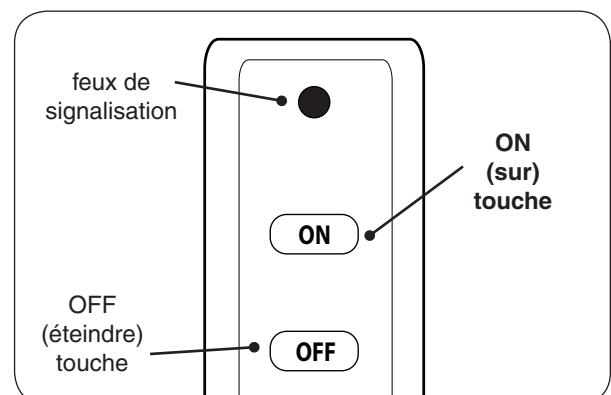


Fig. 28-3 Détail télécommande

MANUAL LIGHTING

CAUTION: DO NOT attempt to light the pilot by hand.

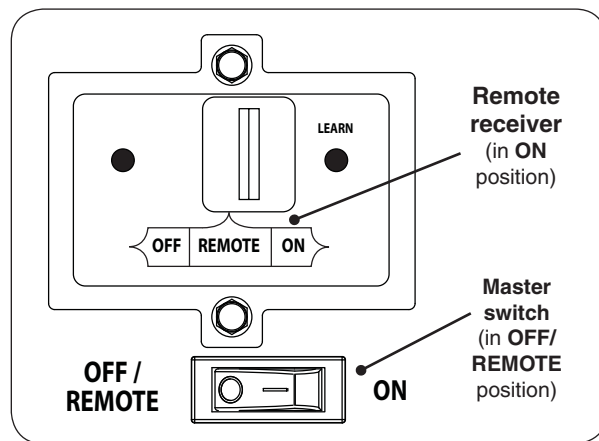


Fig. 29-1 Control panel detail

1. Ensure the master switch is in the **OFF/REMOTE** position (see Fig. 29-1).

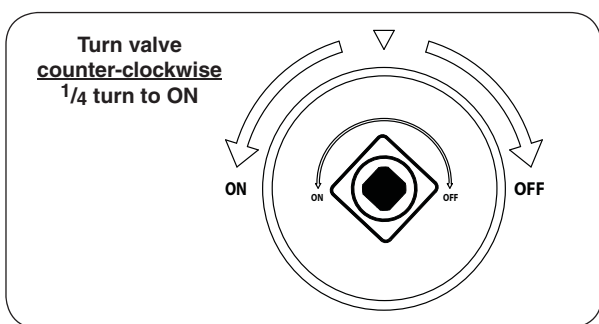


Fig. 29-2 ON/OFF key valve detail

2. Turn the ON/OFF key valve counter-clockwise a $\frac{1}{4}$ turn to the **ON** position (Fig. 29-2).
3. Locate the 3-position switch on the remote receiver (see Fig. 29-1), and slide the switch to the **ON** position.

The remote receiver will emit an audible "beep"; then the ignition sequence will begin. After the pilot lights and is established, the valve will automatically open and the burner will light.

Note: The ignition sequence will take approximately 10 seconds.

WARNING: If the burner fails to light within 10 seconds, slide the remote receiver switch to the **OFF** position. Allow five (5) minutes for any gas in the unit to dissipate, then repeat steps 1-3 above. IF YOU SMELL GAS, SEE STEP B AT BEGINNING OF LIGHTING INSTRUCTIONS.

If the pilot fails to light after several tries, turn all control/remote system components to **OFF** and refer to the TROUBLESHOOTING section for further details.

Note: In manual mode, the remote transmitter will not operate the burner system.

SHUTTING DOWN

For remote shut down, press the **OFF** button on the remote transmitter.

If remote is unavailable, slide the switch on the remote receiver to the **OFF** position.

For emergency shut down, turn the ON/OFF key valve clockwise a $\frac{1}{4}$ turn to the **OFF** position.

MASTER SWITCH

The master switch should remain in the **OFF/REMOTE** position to allow for remote system operation (see Fig. 29-1).

In the event the remote system batteries are dead (or if the system is not functioning) the master switch can be used to turn the burner on and off.

PILOT APPEARANCE

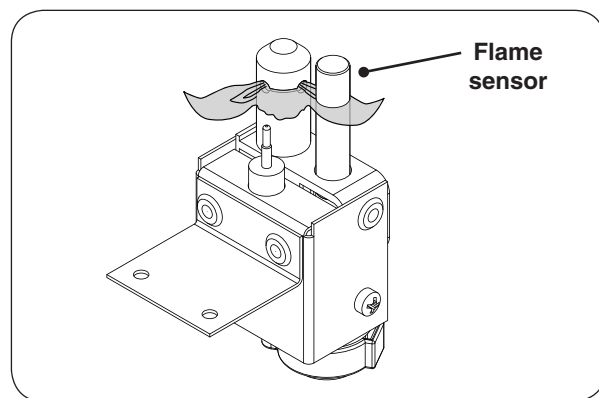


Fig. 29-3 Proper pilot flame

Periodically check the pilot for proper flame pattern. The pilot should be a steady fame, encircling the flame sensor. It is preset at the factory (see Fig. 29-3).

If the pilot flame burns incorrectly: shut down completely and refer to the TROUBLESHOOTING section for further details.

ÉCLAIRAGE MANUEL

ATTENTION: NE PAS essayer d'allumer la veilleuse à la main.

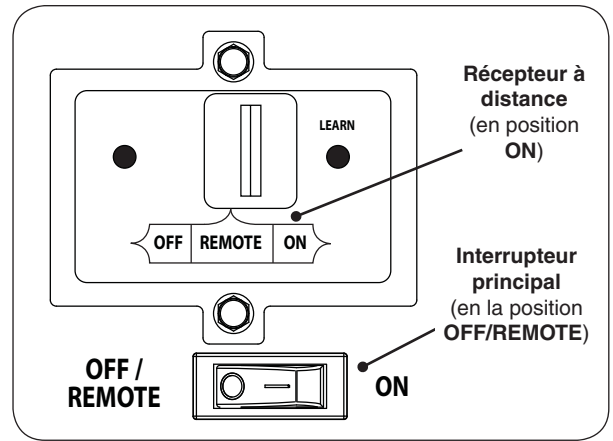


Fig. 30-1 Contrôle détail du panneau

1. Vérifiez que l'interrupteur principal est en position **OFF/REMOTE** (éteindre/éloigné) (voir Fig. 30-1).

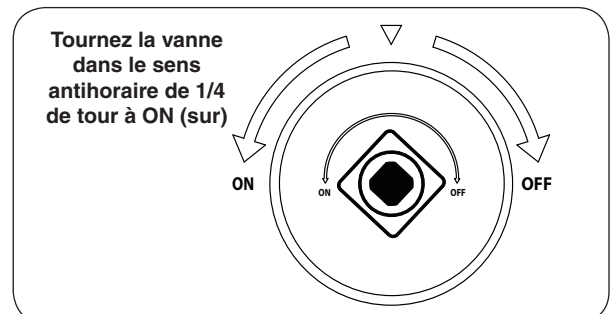


Fig. 30-2 SUR/ÉTEINDRE vanne clé détail

2. Tournez la SUR/ÉTEINDRE vanne clé de la hauteur dans le sens antihoraire de 1/4 de tour à la position **ON** (sur) (Fig. 30-2).
3. Repérez l'interrupteur à 3 positions sur le récepteur de télécommande (voir Fig. 30-1), Et faites glisser le commutateur en position **ON** (sur).

Le récepteur de télécommande émet un "bip" sonore; puis l'allumeur commence à susciter. Après les feux de pilotes et est établie, la vanne se ouvre automatiquement et le brûleur se allume.

Note: La séquence d'allumage prendra environ 10 secondes.

AVERTISSEMENT: Si le brûleur ne parvient pas à allumer dans les 10 secondes, faites glisser le commutateur de récepteur de télécommande à la position **OFF**. Autoriser cinq (5) minutes pour tout gaz dans l'unité à se dissiper, puis répétez les étapes 1-3 ci-dessus. SI VOUS UNE ODEUR DE GAZ, voir l'étape B AU DÉBUT DE instructions d'allumage.

Si le pilote ne parvient pas à allumer après plusieurs essais, tournez tout contrôle / composants du système à distance sur **OFF** et se référer à la section dépannage pour plus de détails.

Note: En mode manuel, la télécommande ne fonctionnera pas le système du brûleur.

ARRÊT

Pour arrêt à distance, appuyez sur le bouton **OFF** (éteindre) de la télécommande.

Si la télécommande ne est pas disponible, faites glisser le commutateur sur le récepteur de la télécommande à la position **OFF** (éteindre).

Pour d'arrêt d'urgence, tourner SUR/ÉTEINDRE vanne clé dans le sens horaire un virage vers la position **OFF** 1/4.

INTERRUPTEUR PRINCIPAL

L'interrupteur principal doit rester dans la position **OFF/REMOTE** (éteindre/éloigné) pour permettre le fonctionnement du système à distance (voir Fig. 30-1).

Dans le cas du système de batteries à distance sont morts (ou si le système ne fonctionne pas) l'interrupteur principal peuvent être utilisés pour allumer le brûleur sur et en dehors.

ASPECT PILOTE

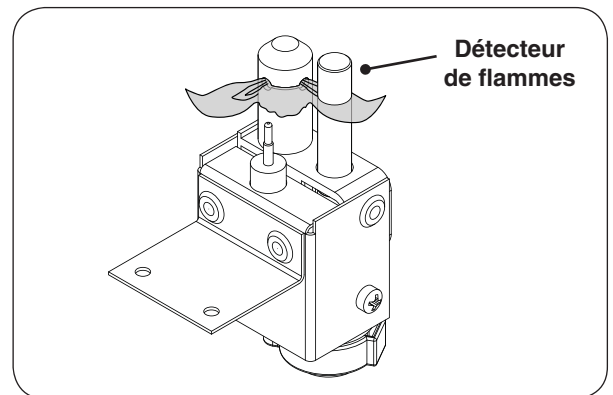


Fig. 30-3 Bonne flamme pilote

Contrôler régulièrement le pilote pour motif de flamme correcte. La flamme de la veilleuse doit encercler le détecteur de flamme, et est préréglé en usine (Fig. 30-3).

Si la flamme de la veilleuse brûle mal: fermer complètement et se référer à la section dépannage pour plus de détails.

SERVICING AND CLEANING

Each installation site for any unit presents its own unique combustion environment. Specific factors such as weather, wind currents, yard debris, altitude, drafts, the size of the surrounding area, all have an influence on the proper operation of the unit. A normally operating unit will demonstrate the following characteristics:

- A lively, realistic yellow flame
- Odor-free

If the flame is not clean (identifiable by excessive sooting on the decorative media), refer to the information below. Some soot on the media may occur and should not be a concern unless excessive.

- Cover your unit whenever it is completely cool and not in use, and follow the guidelines below at least annually.

ANNUAL CLEAN / INSPECTION GUIDELINES

The unit and the installation must be inspected annually. Refer to these instructions for details. Performing these procedures will ensure proper operation, appearance, and safety. WEAR GLOVES.

If maintenance is required, it must be done by a qualified professional service technician.

- Always shut off the gas to the unit while performing service work.
- Allow the unit to cool before servicing.
- The entire burner system should be inspected regularly:

Excessive debris can build up on this unit from leaves, dirt, or other debris. It is critical that all control components, burners, pilot/igniter screen (if applicable), vent openings, and the surrounding area be kept clear and free at all times.

Examine that all components are properly assembled / installed as instructed in this manual.

Ensure that all decorative media is properly placed as instructed in this manual.

Ensure that the pilot/igniter screen on the burner pan is clear of decorative media and any other items/debris.

Replace batteries as needed. See BATTERY INSTALLATION/REPLACEMENT section for details.

- The burner assembly must be replaced prior to the unit being put into operation if it is evident that the burner is damaged. Contact your local dealer for replacement parts.
- DO NOT use substitute materials when replacing any components of the appliance.
- **Keep the vent openings and surrounding area of the unit clear and free at all times.**
- Periodically perform visual checks of the burner flames and pilot flames (if applicable). The burner flames should be blue at the base with a combination of blue/yellow at the body and tips. The pilot (if applicable) should be a steady flame, encircling the flame sensor. Contact a qualified professional service technician for maintenance.
- **To maintain the concrete components**, see the CONCRETE CARE section for details.
- **To maintain the glass wind guard**, see the GLASS CLEANING section for details.
- Any guard or other protective device removed for servicing the appliance shall be replaced prior to operating appliance.
- Verify proper operation after servicing.

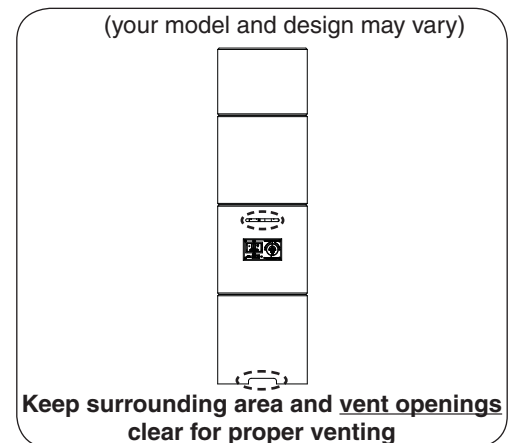

CAUTION: HOT DURING OPERATION AND AFTER USE. Children must be supervised when in the vicinity of this appliance. Serious injury may occur! Children must be alerted to the hazard of high surface temperatures and should stay away to avoid burns or clothing ignition.

CONCRETE CARE

As with any surface, concrete components require regular maintenance and care. Certain guidelines must be followed to preserve the concrete's appearance and structural integrity.

- **Scratches may occur due to usage.** To minimize, avoid striking or dragging heavy, rough, or sharp objects across the unit.
- **Spotting and hairline cracks may occur due to nature of product and are not considered a manufacturing defect.**
- **Concrete products are porous and susceptible to discoloration from liquids.** Avoid allowing water (or any liquid / substance) to stand on the surfaces of the unit.
- **To clean the concrete, first wash with a mild soap and water solution. For stubborn stains, a vinyl brush may be used. Allow to dry. Annually, follow up with a masonry sealer in order to preserve the finish.**
- It should be noted that, like natural stone, concrete products will develop a patina when left outside. No two concrete products are identically the same and the finish will vary.
- **An optional fabric cover is available to protect your unit when cool and not in use (select models).** Contact your local dealer for ordering information.

GLASS CLEANING

- Clean the glass periodically to remove any build-ups caused by the elements and combustion. It is recommended that the glass be cleaned 2-3 times during each heating season, depending on use and environment conditions.
- Clean using a non-abrasive glass cleaner and a clean lint-free cloth.
- Never attempt to clean glass while hot.
- DO NOT touch glass while in operation or within 10 minutes following use.

FUEL CONVERSION KITS

A certified kit is available from the manufacturer to convert your appliance from natural gas to L.P. or vice versa. Contact your dealer for ordering information.

Follow the instructions provided with the kit when converting.

SYNCING THE REMOTE SYSTEM

Ensure the burner system is off and completely cool.

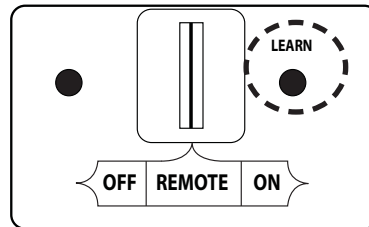


Fig. 33-1 Remote receiver sync detail

Locate the 3-position switch on the remote receiver and slide it to the **REMOTE** position. Use the tip of a pen or a wire clip to push the **LEARN** button and release. See Fig. 33-1. A beep will be heard. Then press and hold the **ON** button on the remote transmitter; a series of beeps should be heard. The remote system is now synced. Refer to the LIGHTING INSTRUCTIONS to test.

BATTERY INSTALLATION/REPLACEMENT

CAUTION: Ensure the unit is connected to the gas line and has been tested for leaks before you insert batteries.

CAUTION: Turn off the burner and allow the unit to completely cool prior to any battery replacements.

Important: Prior to inserting batteries, always apply a small amount of dielectric grease to both ends of each battery. This will ensure conductivity and prevent moisture from affecting the contact.

Important: **Low/dead batteries will affect burner system operation. Replace batteries any time the burner will not turn on.**

Remote transmitter battery

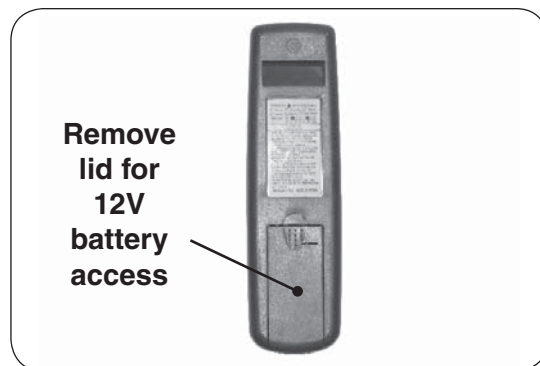


Fig. 33-2 Transmitter battery

The remote transmitter requires 1 12V battery to operate (included). Locate the transmitter, remove the lid (found on rear), and properly insert the new battery as marked. Re-secure the lid. See Fig. 33-2.

Remote receiver batteries

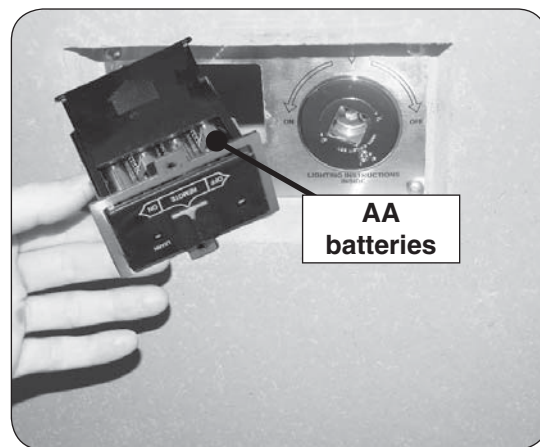


Fig. 33-3 Remote receiver batteries

The remote receiver requires 4 AA batteries to operate (included). Locate the receiver on the control panel, remove the 2 hex screws using a 1/4" nut driver, then pull the receiver (and bracket) out of the control panel. Slide open the lid, and properly insert the new batteries as marked. See Fig. 33-3.

Replace the lid, replace the receiver and bracket, and secure using the 2 screws.

FUSE REPLACEMENT

Ensure the gas to the unit is off and the burner system is off and completely cool.

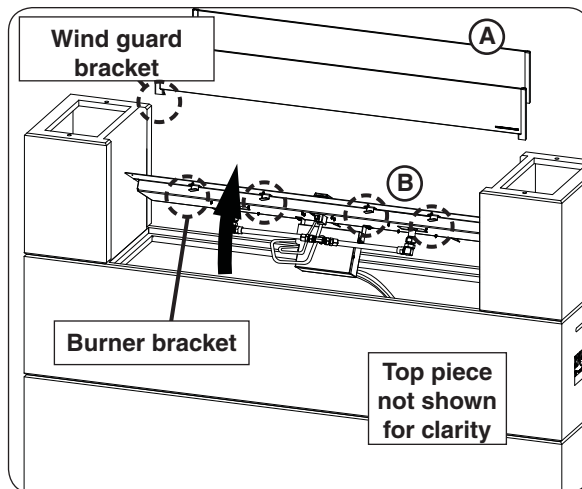


Fig. 34-1 Remove wind guard, then burner assy

1. Remove the wind guard panels from the burner. Use a $\frac{5}{16}$ " nut driver to unfasten the four screws found on the burner assembly. See Fig. 34-1, A.
2. Use a $\frac{5}{16}$ " nut driver to partially unfasten the eight screws found on the burner assembly. Then remove the burner and set it off to the side. See Fig. 34-1, B.

Note: **DO NOT** completely remove the screws - to ensure the burner brackets (beneath) remain assembled.

Remove with care to prevent damage to the electrical and/or gas connections.

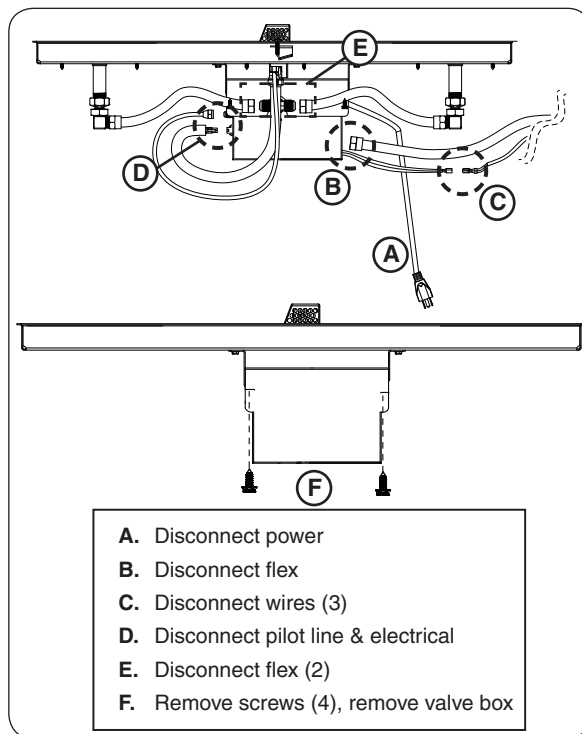


Fig. 34-2 Gain access to valve box

3. Remove the burner and gain access to the valve box as shown in Fig. 34-2.

Proceed to step 4 on the next page.

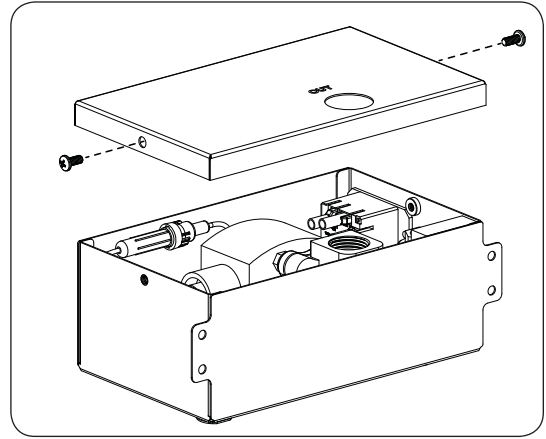


Fig. 35-1 Remove access panel of valve box

4. Use a Phillips screwdriver to remove the access panel of the valve box (see Fig. 35-1).

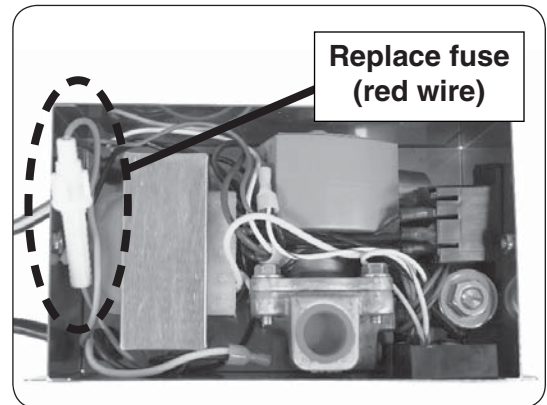


Fig. 35-2 Replace fuse

5. "Push in and twist" the fuse holder (red wire), exposing the fuse (see Fig. 35-2).
6. Replace the fuse accordingly (3AG 2 AMP).
7. Reassemble the fuse holder and access panel. Reinstall the valve box, burner assembly, and wind guard panels.

When replacing burner assembly, ensure the electrical and/or gas connections are clear, undamaged, and completely inserted into the opening. DO NOT pinch the wires.

LEAK TEST: Turn on the gas supply, ignite the burner, and test at all connections for leaks using a soapy water solution. If bubbles appear, a leak is present. Turn off the gas and tighten at all connections. Repeat until no leaks are present. If a leak persists, turn off the gas supply and contact the local gas company or dealer. **NEVER USE A FLAME TO CHECK FOR LEAKS.**

This warranty **does not** apply to: product damage caused by burning wood or any fuel other than natural gas or propane; or damage or discoloration to product used in high wind conditions.

A COPY OF YOUR SALES SLIP FOR PROOF OF PURCHASE IS REQUIRED

This warranty applies to the original purchaser for products which are installed in the United States or Canada and which are operated and maintained as intended for single family residential usage. This warranty is valid only with proof of purchase, shall commence on the date of purchase, and shall terminate (both as to original and any replacement products) on the anniversary date of the original purchase of the product stated on the above schedules.

This warranty covers defects in material and workmanship. This warranty **does not** cover parts which become defective as a result of negligence, misuse, use not in compliance with the Owner's Manual/Installation Instructions, accidental damage, improper handling, improper storage, improper installation, **lack of required routine maintenance** (as specified in the Owner's Manual/Installation Instructions), electrical damage, local gas impurities or failure to protect against combustibles. Product must be installed (and gas must be connected) as specified in the Owner's Manual/Installation Instructions by a **qualified professional installer**. Modifications to products which are not specifically authorized will void this warranty. Accessories, parts, valves, remotes, etc. when used must be Peterson products or this warranty is void. Warranted items will be repaired or replaced at Peterson's sole discretion. This warranty **does not** apply to rust, corrosion, oxidation, or discoloration unless the affected part becomes inoperable.

This warranty **does not** cover labor or labor related charges, except as provided by separate specific written programs from the Peterson Co. All repair work must be performed by a qualified professional service person and requires prior approval of Peterson.

Peterson may require the defective product or part to be returned to the factory to determine the cause of failure. Peterson will pay freight charges if the product or part is determined to be defective. This warranty does not cover breakage in shipment from our (Independent) distributor to its customer if the damage is determined to have occurred during that shipment.

This warranty specifically excludes liability for **indirect, incidental**, or consequential damages. Some states and provinces do not allow the exclusion or limitation of incidental or consequential damages, so the above exclusion may not apply to you. This warranty gives you specified legal rights, and you may have other rights that vary from state to state or province.
